

Norovirus Follow-up Action Plan				
Meeting Date: June 25 <sup>th</sup> , 2018				
Location:	Vancouver Island Conference Centre			
Meeting Objectives:	To have various participants with regulatory roles or interests in vessel discharge within Baynes Sound share information and explore options for and develop an action plan for moving forward.			

This meeting was held in response to the norovirus outbreak attributed to oysters harvested from Baynes Sound in early 2018. Regulatory partners and interested parties came together to share interests and jurisdictional authorities, as they relate to vessel discharge, with the hope of identifying an agreed upon action plan for minimizing the risk of an outbreak occurring in future. Regulatory partners included Transport Canada (TC), Environment and Climate Change Canada (ECCC), Canadian Food Inspection Agency (CFIA), Fisheries and Oceans Canada (DFO), and British Columbia Ministry of Agriculture (AGRI). Industry representatives of the Herring Industry Advisory Board (HIAB) and BC Shellfish Growers Association (BCSGA) were represented. The following is the action plan arrived upon at this meeting. Tracking of progress will be maintained by the Pacific Region Interdepartmental Shellfish Committee (PRISC) Vessel Discharge working group.

While the scope of this meeting was narrowly defined to the co-location of the herring and shellfish aquaculture fisheries in Baynes Sound, the hope is that the discussions and action plan will contribute to larger coordination, discussion and action around overall water quality in support of heathy ecosystems. This work will also support economic opportunities for commercial fisheries and aquaculture and aim to facilitate market access with particular attention to the upcoming audit of the CSSP program by the US.
